Customer Money Protection according to Package Travel Regulation (PRV)

Eurotours Ges.m.b.H. is secured against insolvency by a guarantee from Erste Group Bank AG (Guarantee Declaration No. 618418). The European Travel Insurance AG, Kratochwilstraße 4, 1220 Vienna, telephone +43 1 3172500, acts as the liquidator. Claims must be submitted to the liquidator within 8 weeks of one of the events listed in § 1 (3) PRV, otherwise the claim will be forfeited. Customer funds may not be accepted earlier than 11 months before the agreed end of the trip. A down payment to be made earlier than 20 days before the start of the trip may not exceed 20% of the travel price. Details on the authorization to provide travel services and insolvency protection can be found at www.gisa.gv.at/abfrage under GISA number 21907890.

All information about flight times and airlines is subject to change! Local conditions or current events may sometimes lead to changes in the travel program. If this does not result in a loss of services, it is the responsibility of the local tour guide or Ruefa tour escort to make changes to the itinerary.

Special conditions apply for the special project TCB World Cruise (October 11th to 18th, 2025) according to the Eurotours terms and conditions. The organizer Eurotours Ges.m.b.H. expressly

points out that the prevention of artists for special reasons does not entitle to free or reduced cancellation of the trip. The trip itself will take place in any case and is subject to the published cancellation policy. In the unexpected event of an artist cancellation, if the event package cannot be fully provided as part of the overall package, the event organizer TCB is only obliged to refund the portion of the event package that was not provided.

Visa and Entry

Every traveler needs a passport or identity card valid for at least 6 months after the end of the trip. Please note that Costa generally requires travel

documents to be valid for 6 months after the end of the trip, even if individual countries have less strict requirements. Children up to the age of 12 (including those under 10 years old) generally require a child passport with a photo. However, in some countries, a regular passport may also be required for children as an entry document. Due to the often non-uniform practice at immigration and sometimes last-minute changes, we strongly recommend that you inform yourself again about the current entry requirements, especially for children, shortly before the start of your trip. German citizens can find information on the website of the Federal Foreign Office (www.auswaertiges-amt.de), among others. Austrian citizens can find information on the website of the Federal Ministry for European and International Affairs (www.bmeia.gv.at).

For visa applications, we recommend using the comprehensive, fee-based service of CIBT VisumCentrale GmbH at www.cibtvisas.de/costa or by calling +49 (0) 30 / 230 95 91 75 at the Costa preferential rate. The information provided on entry and health regulations applies to guests with German and Austrian citizenship, unless there are special circumstances (such as dual citizenship or primary residence abroad). Please note that entry without sufficient and valid travel documents can lead to significant costs for the respective traveler. Furthermore, entry into some countries may be difficult if your identification document has been reported lost or stolen before (e.g., Croatia). If this applies to you, please contact the relevant embassy separately for information in advance. In addition to the aforementioned travel documents, German and Austrian citizens do not need a separate visa for most destinations. Please note the exceptions or special regulations

regarding passport and visa requirements for individual destinations listed below. If you wish to stay in the destination area after the end of the cruise, please inform yourself about the necessary residence permits. The ship's manifest with your personal data must be completed on www.mycosta.com after booking.

Vaccinations and Health

All guests on board are strongly recommended to be fully vaccinated against COVID-19. There is currently no vaccination requirement. People with disabilities are asked to inform us when booking. This trip is barrier-free.
